Linkage for Faculty Exchange/Student Exchange

This memorandum of Understanding (here in after referred to as MoU) is made and entered into on this day, the 22nd of Oct. between **SANT SHIROMANI GURU RAVIDAS GOVT. COLLEGE, SARGAON , DISTT. – MUNGELI, C.G.** and **VEERANGANA AWANTI BAI LODHI GOVT. COLLEGE , PATHARIA, DISTT.- MUNGELI , C.G.** for a period of 5 years from the academic year 2019-2024 for faculty/student exchange,

1- OBJECTIVE OF THE MOU:

1. To provide the environment of knowledge sharing of both institutions.
2. To provide interaction among the student of both the institutions.
3. To provide an opportunity to faculty and student to share knowledge on curricular, co-curricular and extra-curricular activities.

2. PROPOSED TERMS COLLABORATION:

1. Both the institution will mutually agree for guest lectures and relieve and teachers of respective subject.
2. At least 15 days before, the invitation letter for the guest lectures will be sent to the teachers or they will be conducted through their mobile number.
3. No traveling expenses will be provided to teachers/student
4. No allowances shall be paid to the visiting teachers/student.
5. All the necessary arrangements for the guest lecture will be made by the host institution.

3. NON EXCLUSIVITY:

Both the parties are free to pursue other agreements of any kind and the relationship of the both parties shall be nonexclusive under this MoU.

4. TERMS OF TERMINATION:

This MoU shall be expired after 5 years by mutual written agreement of both the parties. 60 days prior written notices to serve by either of the partly for unilaterally terminates MoU.

5. **RELATIONSHIP:**

Nothing in this MoU shall be constructed to make either of the parties a partner, an agent or a legal of the other for any purpose.

6. **OUTCOME:**

The outcome of the MoU consists of student and faculty exchange between the institutions in order to enhance the quality academic environment in the field of education.


