This Memorandum of understanding (here is after referred to as MoU) is made and entered into on this day, the Eighteenth, August 2022 between LCIT College of Commerce and Science Bodri Bilaspur (CG) and Sant Shiromani Guru Ravidas Govt. College, Sargaon, Mungeli (CG)

For a period of 5 years from the academic year 2022-2027 for faculty/student exchange.

1. OBJECTIVES OF THE MOU:

1. To provide the environment of knowledge sharing of both the institutions,
2. To provide interaction among the student of both the institution,
3. To provide an opportunity to faculty and students to share knowledge on curricular, co-curricular and extra-curricular activities,

2. PROPOSED TERMS OF COLLABORATION:

1. Both the institution will mutually agree for guest lectures and relieve teachers of respective subject,
2. At least 15 days before, the invitation letter for the guest lectures will be sent to the teachers or they will be contacted through their mobile number,
3. No travelling expenses will be provide to teachers /student,
4. No allowances shall be paid to the visiting teachers/students,
5. All the necessary arrangement for the guest lecture will be made by the host institution.

3. NON EXCLUSIVITY:

Both the parties are free to pursue other agreements of any kind and the relationship of the both the parties shall be non exclusive under this MoU.

4. TERMS OF TERMINATION:

This MoU shall be expired after 5 year by mutual written agreement of both the parties. 60 days prior written notice to serve by either of the party for unilaterally terminates MoU.


5. RELATIONSHIP:

Nothing in this MoU shall be construed to make either of the parties a partner, an agent or a legal representative of the other for any purpose



6. OUTCOME:



