Linkage for Faculty Exchange/Student Exchange

This Memorandum of Understanding (here in after referred to as MoU) is made and entered into on this day, the First of July, 2017 between **D. L. S. P. G. College, Bilaspur, Chhattisgarh** and **Sant Shiromani Guru Ravidas Govt. College, Sargaon, Distt.- Mungeli, Chhattisgarh** for a period of 5 years from the academic year 2017-2022 for faculty/student exchange.

1. OBJECTIVES OF THE MOU:

1. To provide the environment of knowledge sharing of both the institutions.
2. To provide interaction among the students of both the institutions.
3. To provide an opportunity to faculty and students to share knowledge on curricular, co-curricular and extra-curricular activities.

2. PROPOSED TERMS OF COLLABORATION:

1. Both the institutions will mutually agree for guest lectures and relieve teachers of respective subjects.
2. At least 15 days before, the invitation letter for the guest lectures will be sent to the teachers or they will be contacted through their mobile number.
3. No travelling expenses will be provided to teachers/students.
4. No allowances shall be paid to the visiting teachers/students.
5. All the necessary arrangements for the guest lecture will be made by the host institution.

3. NON EXCLUSIVITY:

Both the parties are free to pursue other agreements of any kind and the relationship of the both the parties shall be nonexclusive under this MoU.

4. TERMS OF TERMINATION:

This MoU shall be expired after 5 years by mutual written agreement of both the parties. 60 days prior written notice to serve by either of the party for unilaterally terminates MoU.


5. RELATIONSHIP:

Nothing in this MoU shall be construed to make either of the parties a partner, an agent or a legal representative of the other for any purpose.

6. OUTCOME:



The outcome of the MoU consists of student and faculty exchange between the Institutions in order to enhance the quality academia environment in the field of education, technology and R&D.


